1. Tender was invited by BMRCL for the work of Shifting of BESCOM Utilities which are infringing the Elevated Metro Corridor (Viaduct & Stations) alignment between Central Silk Board, Lowry Memorial School and KR Puram along ORR, Phase-2. Based on the evaluation carried out by the nominated committee, your firm was found to be the lowest acceptable tenderer.
2. Accordingly, work was awarded to your firm vide Letter of Award on 12.12.2018. you have submitted a document on 07.02.2019 representing it to be the Bank Guarantee No. 6945/SBI/BG/0073/2019 Dated : 05.02.2019 issued by SBI Bank, Nariman Point Branch, Mumbai-400021 for an amount equal to 10% of the Contract Value i.e. Rs. 91,51,147/- (Ninety One Lakh Fifty One Thousand One Hundred and Forty Seven only) as Performance Security Deposit. Since the Bank Guarantee is required to be payable at any specified branch in Bangalore, BMRCL asked for amendment to the Bank Guarantee to the effect that the bank guarantee is payable and encashable at the specified branch in Bangalore. Accordingly, you have submitted the amendment dated: 12.02.2019 to the bank guarantee showing it as encashable or extendable at State Bank of India, St Marks Road Branch, Ashoknagar, Bangalore, purportedly issued by the SBI, Nariman Point Branch, Mumbai.
3. BMRCL written a letter to SBI Bank, Nariman Point Branch, Mumbai for Confirmation of Bank Guarantee submitted by M/s Vijaya Energy Plus Pvt Ltd. SBI Bank, Nariman Point Branch, Mumbai informed by return E-mail that the Bank Guarantee is not issued by their Branch and BG is found to be Fraudulent.
4. In view of the above, BMRCL has already taken action for encashment of the Tender Security/ EMD, Lodging Police Complaint and Cancellation of Letter of Award & Contract Agreement made with the firm.

Ltd., from participating in any of the BMRCL's Tenders for the next five (5) years with effect from date of issue of this letter.
